## [Ontario Film and Television Tax Credit \(OFTTC\)](#)

**Description:** Ontario refundable tax credit for film and video productions.

## [Ontario Production Services Tax Credit \(OPSTC\)](#)

**Description:** Ontario refundable tax credit for qualifying labour expenditures for those productions that do not meet the Canadian content requirements.

**Description:** A refundable tax credit available to employers who hire and train apprentices in certain skilled trades.

**Description:** Contributions for employers to hire students during the summer.

## [Cooperative Education Tax Credit \(CETC\)](#)

**Description:** A monetary bonus for an employer who hires and registers an apprenticeship scholarship candidate as an apprentice.
